TERMS

Buyer agrees to pay in full the sale price of any and all items charged to Buyer's account the following Monday for the previous weeks purchases.

In the event that the account is not paid in full within the above terms, buyer thereafter agrees to pay in addition to the charges for items purchased, a monthly FINANCE CHARGE of 1% (18% ANNUAL PERCENTAGE RATE) on the unpaid monthly balance up to but not exceeding the first \$500.00, and a monthly FINANCE CHARGE of 1% (12% ANNUAL PERCENTAGE RATE) on the unpaid monthly balance exceeding \$500.00. No FINANCE CHARGE will accrue if the entire balance is paid in full to BARRCO AUTOMOTIVE WAREHOUSE DISTRIBUTORS, Inc. by the 20th of the following month of said date of purchase. The FINANCE CHARGE is computed on the previous 2nd month's unpaid balance.

Buyer further agrees that if this account is overdue and is placed with another for collection, to pay, in addition to the principal amount thereof with interest, and other lawful charges, all costs and expenses of collection including any attorney's fee in the amount of 33 1/3% of the amount owing including FINANCE CHARGES.

Buyer has carefully read this agreement and understands the obligations and terms hereof and has procured credit from BARRCO AUTOMOTIVE WAREHOUSE DISTRIBUTORS, INC. based upon the Buyer's representations and hereby agrees to the terms herein noted.
